Instructions for Completing an Absent Applicant Affidavit Please Read Carefully

Texas law has changed and you are no longer able to name a Proxy to stand in for you at the ceremony <u>unless you are a member of the Armed Forces</u>. If you are not in the Military and not able to **ATTEND** the ceremony, we **CANNOT** issue a Marriage License!

The AFFIDAVIT OF ABSENT APPLICANT is to be used to apply for a Marriage License when one party is unable to appear in the County Clerk's Office. Please read the following instructions carefully before completing the Affidavit. The applicant must print all information that is requested on the attached Affidavit. The absentee party must return the completed Affidavit to the party they wish to marry. Both parties desiring to marry must be in full compliance with the information that follows or the application will be denied.

- 1. The party who will not be able to appear in the County Clerk's Office must complete and sign this form in the presence of a Notary Public. The Notary's name & title must appear below the signature and their stamp must be applied.
- 2. The names of both parties must be printed exactly as they appear on the identification that will be used to obtain the Marriage License.
- 3. The applicant must appear in any County Clerk's office in the State of Texas at least 72 hours, but not more than 90 days prior to the ceremony. The applicant must present an acceptable form of **PHOTO** identification for both parties that states the correct name and date of birth of each applicant, such as: valid driver's license (or one that has not been expired longer than 2 years) military ID, state issued ID or a valid passport.

UNDER NO CIRCUMSTANCES WILL WE ACCEPT AN ALTERED DOCUMENT AS PROOF OF IDENTITY.

- 4. The 72 hour waiting period does not apply to active duty military personnel.
- 5. If either party has been divorced in the last 30 days or if either party is under 18 years of age, please contact the County Clerk's office for more information.

AFFIDAVITS EXPIRE 30 DAYS FROM THE DATE SIGNED BY THE NOTARY. IF IT IS NOT USED IN THAT TIME PERIOD A NEW ONE MUST BE OBTAINED.

Marriage Licenses are not issued after 4:00 p.m. Monday – Thursday and 3:00 p.m. Friday

Cost of Marriage License is \$81.00. No checks accepted. Acceptable forms of payment are cash or Credit/Debit Card with an additional \$3.00 convenience fee. For any questions, please call (512) 332-7234.
