

ORDER SETTING BASTROP COUNTY, TEXAS TAX RATE FOR 2014

Whereas, the Bastrop County Commissioners Court for 2014, in order to provide funds with which to meet the budget requirements of the County, and to pay the expenses necessarily incurred in connection with the services provided by the County to Bastrop County residents: therefore,

BE IT ORDERED BY THE COMMISSIONERS COURT:

1. That there is hereby levied and there shall be assessed and collected for 2014 an ad valorem tax of \$.6290 per \$100 assessed valuation on all taxable property within the county as shown on the final approved 2014 tax rolls of the county. This tax rate will raise more taxes for maintenance and operations than last year's tax rate.

This tax rate is hereby adopted in the following components:


General Fund Maintenance and Operating Tax Rate	\$ .4188
Debt Service Tax Rate	\$ .0968
Road & Bridge Maintenance and Operating Tax Rate	\$ .1134
2014 Total Ad Valorem Tax Rate	\$ .6290

2. For comparison purposes, a \$100,000 home (not allowing for exemptions), paid \$629.00 to Bastrop County in 2013. In 2014 the same house, at the same value, would pay \$629.00. This tax rate will retain taxes for maintenance and operation on a \$100,000 home at the same dollar amount as the previous year (\$629.00).
3. That the Bastrop County Tax Assessor/Collector is hereby authorized and directed to prepare 2014 tax statements and transmit the same to the owners of taxable property within the County on or before October 1, 2014, or as soon thereafter as possible.
4. The total effective tax rate for 2014 is \$.6290. The total effective maintenance & operating rate for 2014 is \$.5322. The 2014 total rollback rate \$.6775.


