BASTROP COUNTY MUNICIPAL UTILITY DISTRICT NO. 4

Notice is hereby given that the Board of Directors of Bastrop County Municipal Utility District No. 4 (the "District") will hold a regular meeting on **Friday, January 9, 2026, at 12:00 p.m.**, at the offices of Allen Boone Humphries Robinson LLP, 919 Congress Avenue, Suite 1500, Austin, Texas 78701, to discuss and, if appropriate, act upon the following items:

1. Comments from the public.
2. Approve minutes.
3. 2024 Directors Election, including:
 - a. approve and distribute Certificates of Election; and
 - b. approve Directors' Sworn Statements and Oaths of Office.
4. Authorize execution of District Registration Form.
5. 2026 Directors Election, including:
 - a. adopt Resolution Designating an Agent of the Secretary of the Board of Directors During the 2026 Directors Election Period;
 - b. authorize Notice of Deadline to file Applications for Place on the Ballot;
 - c. approve contracting for election services and any associated agreements if necessary with Bastrop County;
 - d. consider use of electronic voting system and authorize notice of exemption;
 - e. set pay for election officials;
 - f. adopt Order Calling Directors Election; and
 - g. authorize Notice of Election.
6. Financial and bookkeeping matters, including payment of the bills, review of investments, and adopt budget for fiscal year end February 28, 2026.
7. Accept disclosure statements for Investment Officers and bookkeepers.
8. Engineering matters, including preparation of plans and specifications, approval of plans and specifications, advertisement for bids, contract award, joint construction agreements, Pay Estimates and Change Orders, acceptance of projects, and direct engineer to notify insurance company, as appropriate.
9. Water and wastewater matters and agreements, including Wholesale Service Agreement with Aqua Water Supply Corporation.
10. Deeds, easements, consents to encroachment, requests for service, out-of-district service agreements, and utility commitment letters.
11. Report on development, including approve development financing agreements, assignment of development financing agreements, and consents to assignment of reimbursements, if appropriate.
