**BRIEF EXPLANATION OF SUBJECT OF PUBLIC HEARING**

The District proposes to amend Sections 1, 3, 5, 6, 7, 8, 10, 13, 14, and 15 as follows:

Section 1. The District proposes to amend Rule 1 (Definition of "District Office").

Section 3. The District proposes to amend Rule 3.1.A(1) and add Rule 3.1.A(4) (Exempt Wells).

Section 5. The District proposes to amend Rule 5.2.C and 5.2.D (Processing of Operating Permit Application), and Rule 5.5.B (Time Limit for Completion of Permitted Well).

Section 6. The District proposes to add Rule 6.4.B (Transport Permit Provisions).

Section 7. The District proposes to amend Rules 7.7.B and 7.7.C (Replacement Wells) and to add Rule 7.8 (Permit Surrender).

Section 8. The District proposes to amend Rules 8.3.B and 8.3.C (Well Spacing Variances).

Section 10. The District proposes to add Rule 10.4 (Permit Authorization Documentation).

Section 13. The District proposes to amend Rule 13.3 (Penalties for Violation of District Rules), and add Rule 13.7 (Settlement of a Notice of Violation).

Section 14. The District proposes to amend Rule 14.3.B (Procedures for Petitions for Rulemaking).

Section 15. The District proposes to amend Rule 15.1.C (Notice for Permit Applications Requiring Public Hearing).
