**NOTICE OF MEETING**

2. Approve minutes.
3. Financial and bookkeeping matters, including payment of the bills, review of investments, tax report, and depository pledge agreements.
4. Operations matters, including operation of District facilities, billings, repairs, maintenance, adopt amended Rate Order, if appropriate, hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
5. City of Bastrop wholesale water service matters, including Wholesale Water Agreement, amendment thereto, and authorize appropriate action.
6. Engineering matters, including authorize design; approve plans and specifications and authorize advertisement for bids; review bids and award contracts; authorize execution of development permit; assignment of construction contracts; approve pay estimates, change orders, and final acceptance; and direct engineer to notify insurance company of new facility, as appropriate, for construction in the service area, including for the following:
  - a. West Bastrop Village Phase 1, Major Tract, Sections 2, 3, and 4 - Street Excavation, Drainage, Water, Wastewater, Erosion Control and Grading Improvements;
  - b. West Bastrop Village Phase 1 Section 5 - Street Excavation, Drainage, Water, Wastewater, Erosion Control and Grading Improvements; and
  - c. Texas Department of Transportation Donation Agreement for Adelton Blvd. and FM 20 traffic signal.
7. Deeds, easements, consents to encroachment, requests for service, utility commitment letters, utility conveyances, and Phase I environmental site assessment proposals.
8. Park and recreation matters, including authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award contracts, contract amendments; approve pay estimates, change orders, and

  - b. West Bastrop Village - Park - Sitework, Planting and Irrigation;
  - c. West Bastrop Village - Parks & Trails 1-3 & 1-4 (fka West Bastrop Village - Phase 1 - Section 2 Park - Sitework, Planting and Irrigation); and
  - d. West Bastrop Village - Pond Park 1-3.
9. Maintenance and repair of District facilities, including drainage, detention, and landscaping facilities, approve proposals and service agreements related thereto, and approve maintenance agreement with Adelton Residential Master Community HOA, Inc.
  10. Review and update Eminent Domain Report to the Texas Comptroller.
  11. Development matters, including report on development, development financing agreement, and consent to assignment of reimbursement rights.
  12. Discuss and take any necessary action related to West Bastrop Village Section 1, Phase 1 and Offsite Wastewater - Street Excavation, W/W/D, Erosion Control and Grading.
