## ORDER SETTING THE BASTROP COUNTY, TEXAS TAX RATE FOR 2024-2025

WHEREAS, the Bastrop County Commissioner's Court for the tax year 2024-2025 needs to adopt a tax rate in order to provide funds with which to meet the budget requirements of the County, and to pay the expenses necessarily incurred in connections with the services provided to the County of Bastrop residents:

THEREFORE, BE IT ORDERED BY THE COMMISSIONER'S COURT:

 That there is hereby levied and there shall be assessed and collected for 2024-2025 an ad valorem tax of \$0.40275 per \$100 assessed valuation on all taxable property within the county. THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

This tax rate is hereby adopted in the following components:

- 2. THE TAX RATE WILL EFFECTIVELY BE RAISED BY 2.34 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE & OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$5.57
- 3. That the Bastrop County Tax Assessor/Collector is hereby authorized and directed to prepare the 2024 tax roll for submission to the Commissioner's Court for approval in accordance with Texas Property Tax Code 26.09 (e).
- 4. The total no-new-revenue tax rate for 2024 is \$0.38231 per \$100 of taxable valuation. The total voter-approval tax rate for 2024 is \$0.41152 per \$100 of taxable valuation.
