## **ITEMS FOR ADDENDUM #1:**

**Q:** Will the county accept a deviation letter with a minimum order of \$5,000 for free freight? This allows us to be more competitive.

A: Yes

**Q:** Could you verify the requested "3 ¼" round yellow high intensity delineators" is infact .080 gauge aluminum or if the plastic delineator with center hole is needed?

### **A: .**080 gauge

**Q:** Will a 5.5" blade holder be acceptable in place of requested 5 ¼" for the Round post and U channel brackets? **A:** Yes

**Q:** Safety flags Many options/styles out there. Will the below suffice?

- 18" x 18" orange vinyl flag
- 3/4" diameter wood dowel is 24" long
- Compatibility: 18" flags are suitable to mount above a traffic control sign or device. Place flags in a flag bracket, sold separately

### A: Yes

Q: Are the barricade lights just to have yellow lens?

A: Yes

**Q:** For the barricade lights some manufacturers discontinued the 6 volt. Will the below Type A/C 3 Volt suffice? **A:** Yes

Q: With many variations of plastic barricades available, which models does Bastrop County want bid?

**A:** Bastrop County request that you list the prices of all available variations that your company has the ability to sell. You can add additional pricing for multiple variations on the attached "Additional Bid Item Price Sheet".

**Q:** Is there any Buy American act applicable or an international product is allowed?

**A:** There is NO requirement for Buy American only products. Bastrop County does its best to buy American made products, but they are not required for this bid.

**Q:** What could be the minimum quantity order and what could be frequency of orders?

**A:** There is no minimum quantity for an order, all orders are based on needs at the time of request. Bastrop County is moving to a new method of ordering sign shop materials and will start placing large bulk order twice a year but fully anticipates having small orders placed throughout the year.

Q: Does the scope include any labor as well or is this just a dropship bid?

**A:** Bastrop County is only requesting purchase price of materials. All labor is provided by Bastrop County.
